

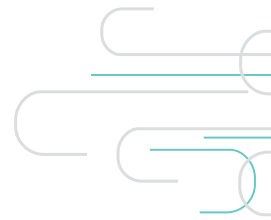


Healthcare Investor Licensing Guide

Introduction

The objective of this guide is to provide a reference to investors in the private health sector to familiarize themselves with the general regulations, requirements and procedures for obtaining healthcare licenses, as well as identify the necessary approvals in accordance with the activities to be exercised.

Hence, this guide shall not be deemed complete, without reference to the Private Health Institutions Law and its Executive Regulations, issued by Royal Decree No. (M/40) dated 1423/11/3 H., as well as the Law of Pharmaceutical Establishments and Preparations, issued by Royal Decree No. (M/31) dated 1425/6/1 H. and its Executive Regulations, and the Law of Practicing Healthcare Professions, issued by Royal Decree No. (M/59) dated 1426/11/4 H., and its Executive Regulations No. (4080489) dated 1439/1/2 H.

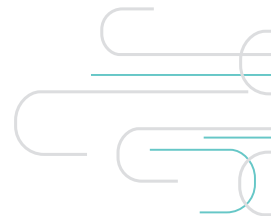

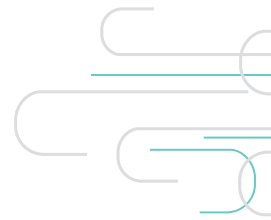

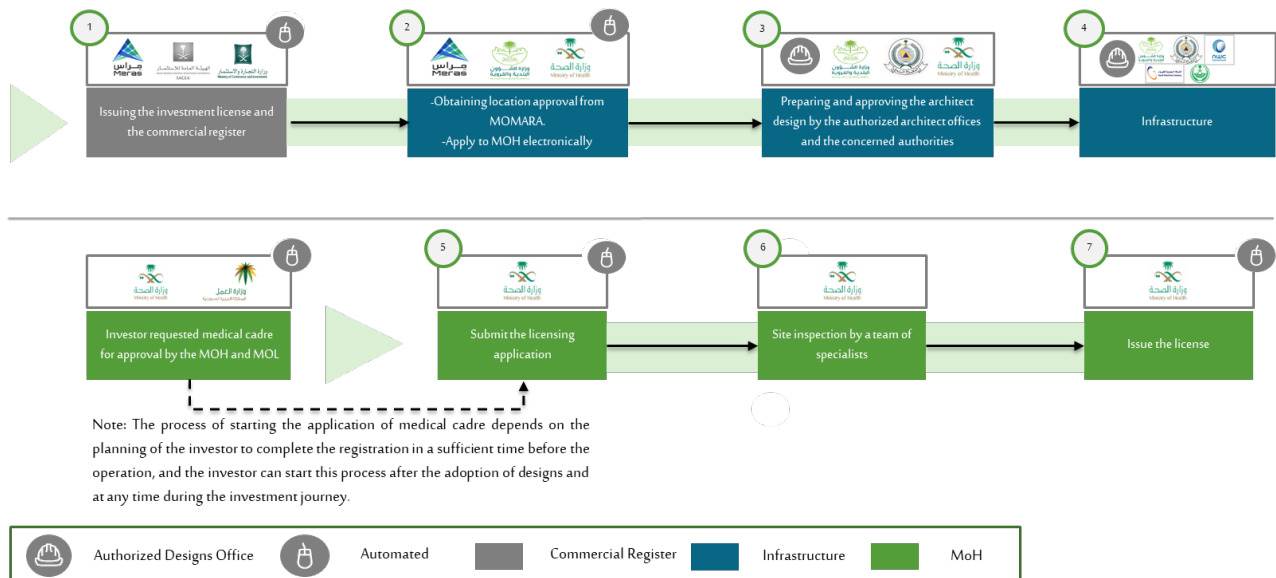


Hospital Licensing

Hospitals:

A private health facility, designed to receive and provide patients with appropriate medical treatment, while undergoing necessary medical examinations and tests, through a specialized, medical cadres and integrated medical devices. The hospital A private health facility, designed to receive and provide patients with appropriate medical treatment, while undergoing necessary medical examinations and tests, through a specialized, medical cadres and integrated medical devices. The hospital may be a general or specialized, providing extended medical care, recovery and drug rehabilitation services, among others.

Hospital License Issuance Requirements



First Step :Prerequisites for Applying for a Hospital License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the land's suitability.

Second Step :Requirements for Initial Approval Issuance

The private hospital establishment application shall be submitted through SEHA platform ,indicating the hospital specialty ,number of beds and location ,and to which the following documents shall be attached:

- A copy of the investor's ID in the event of an individual ownership ,(or a copy of the company's Article of Association ,along with the partners 'ID cards) in the event of collective ownership.(

- A copy of the land title deed ,or a copy of the 15-year land lease.
- Initial architect design ,approved by an authorized architect office specialized in the design of health facilities.

Third Step: Issuance of Relevant Licenses and Approvals

- Submit final architect design to the Ministry of Health.
- Obtain and submit the approval of the Directorate of Health Affairs ‘Cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.

Fourth Step: Hospital License Issuance Requirements

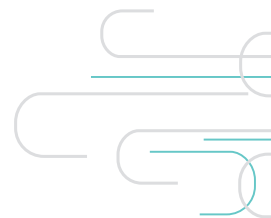
Once the hospital construction project is completed, the investor shall apply for the opening and operation of the hospital, and ensure that the following documents are attached:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification and registration of medical cadres, issued by the Saudi Commission for Health Specialties.

The investor shall obtain the license after the sight inspection by the Directorate of Regional Affairs and ensure that the necessary requirements for the hospital is completed and compliance with the regulations and instructions within 20 working days

Minimum Number of Beds to Be Provided in Hospital According to the Licensed Specialties:

Minimum cadres and the Requirements to be provided in hospitals:

Managing director	<ul style="list-style-type: none"> To have adequate experience and training to manage the hospital.
Medical director	<ul style="list-style-type: none"> To hold a Bachelor of Medicine and Bachelor of Surgery, and have 3 years of experience.
Head of nursing	<ul style="list-style-type: none"> To be qualified, and have a minimum of five years of experience in the nursing supervision field.
Physicians	<ul style="list-style-type: none"> To appoint consultants, registrars and residents by specialties. The consultant shall supervise up to 30 beds. The registrar shall supervise up to 20 beds. The resident shall supervise up to 25 beds at a time.
Minimum number of Physicians, specialists and technicians	<ul style="list-style-type: none"> To ensure the coverage of support medical services, such as the laboratory and imaging center, continuously.
Nursing	<ul style="list-style-type: none"> To ensure the coverage of internal services, outpatient clinics, emergency, intensive care and operations.

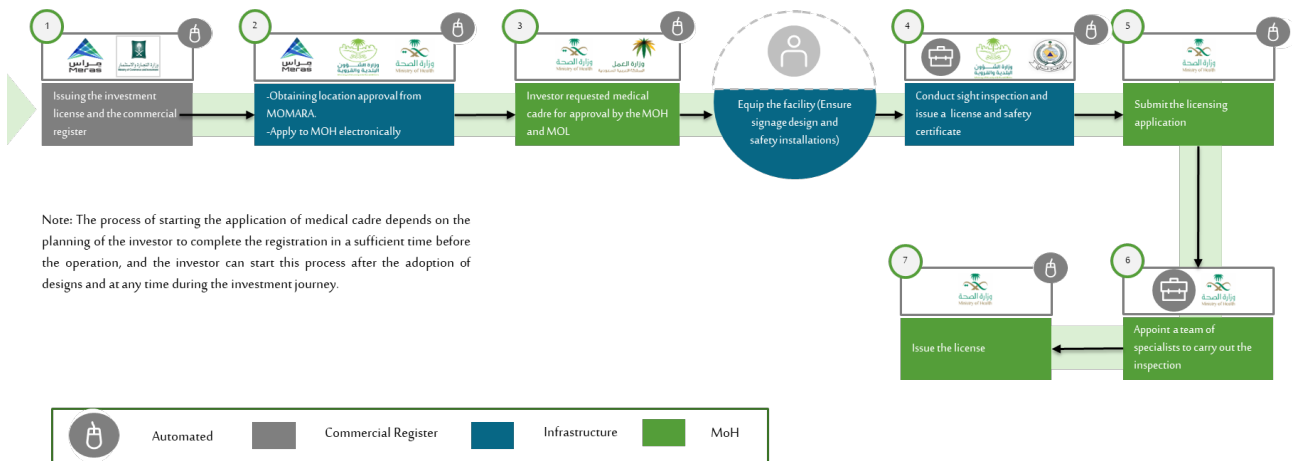

General Polyclinic Licensing

General polyclinic:

A private health facility, designed to receive and undergo patients to necessary medical examinations, tests and treatments, encompassing a minimum of 3 different medical specialties from among the following basic branches: Surgery, Internal Medicine, Obstetrics and Gynecology, Pediatrics, and Family Medicine.

General polyclinic License Issuance Requirements



First Step : Prerequisites for Applying for a General Polyclinic License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

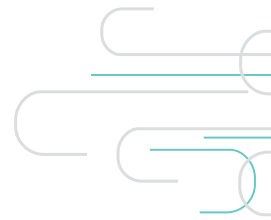
Second Step: Requirements for Initial General polyclinic Approval Issuance

The General polyclinic establishment application shall be submitted through SEHA platform, indicating the polyclinic specialty, and to which the following documents shall be attached:

- A copy of the investor's ID (in the event of an individual ownership), or a copy of the company's Article of Association, along with the partners' ID cards (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.



Fourth Step: General polyclinic License Issuance Requirements

Upon the completion of all medical and administrative requirements and providing three minimum clinics, one of which are basic specialties (General Surgery, Internal Medicine, Obstetrics and Gynecology, Pediatrics, and Family Medicine). In addition to an emergency department as well, the investor shall apply for the license, while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification and registration of medical cadres, issued by the Saudi Commission for Health Specialties.
- A copy of the ambulance documents, provided that its model dates back to no less than five years, or a copy of an agreement concluded with a private or governmental emergency transportation service center.

The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within ten working days.

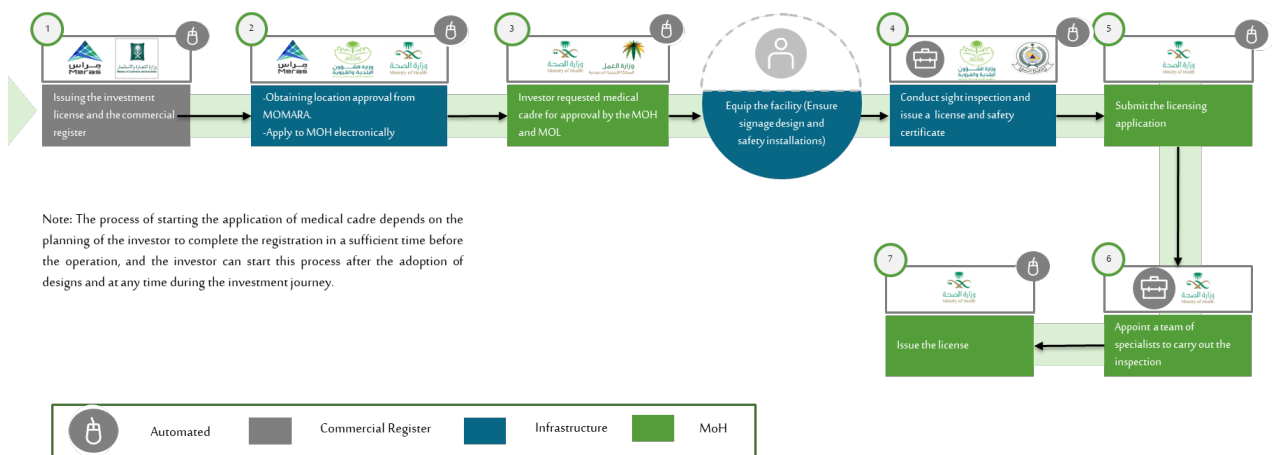

Specialized Polyclinic Establishment Licensing

Specialized Polyclinic:

A private health facility, designed to receive and undergo patients to necessary medical examinations, tests and treatments, encompassing a minimum of 3 integrated clinics dedicated to each medical specialty. The specialized Polyclinic is more specialized than the general Polyclinic, although it does not have stay-in rooms nor an ambulance room.

Specialized Polyclinic License Issuance Requirements



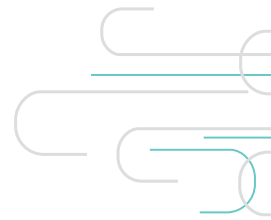
First Step: Prerequisites for Applying for a Specialized Polyclinic License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

Second Step: Requirements for Initial Specialized Polyclinic Approval Issuance

The specialized Polyclinic establishment application shall be submitted through SEHA platform, indicating the Polyclinic specialty, and to which the following documents shall be attached:

- A copy of the investor's ID (in the event of an individual ownership), or a copy of the company's Article of Association, along with the partners' ID cards (in the event of collective ownership).
- A copy of the lease or title deed.



Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs 'medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.

Fourth Step: Specialized Polyclinic License Issuance Requirements

Upon the completion of all medical and administrative requirements and providing three minimum clinics for each specialty in the Polyclinic specialties, the investor shall apply for the license, while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
 - Copies of the classification of medical cadres, issued by the Saudi Commission for Health Specialties.
- The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within ten working days.

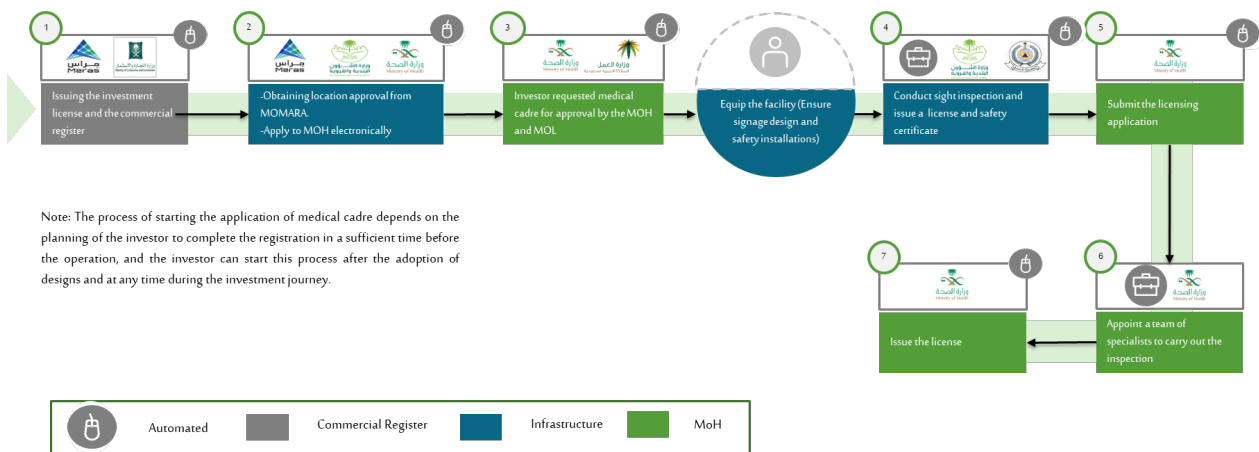

Radiology Center Establishment Licensing

Radiology center:

A specialized center in charge of carrying out radiology examinations and providing medical reports thereon.

Radiology Center License Issuance Requirements



First Step: Prerequisites for Applying for a Radiology Center License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

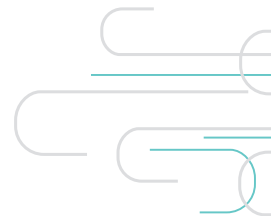
Second Step: Requirements for Initial Radiology Center Approval Issuance

The Radiology center establishment application shall be submitted through SEHA platform, indicating the facility type, and to which the following documents shall be attached:

- A copy of the investor's ID in the event of an individual ownership, (or a copy of the company's Article of Association, along with the partners' ID cards (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.



Fourth Step: Radiology Center License Issuance Requirements

Upon the completion of all medical and administrative requirements of the Radiology center ,the investor shall apply for the license ,while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
 - Copies of the classification of medical cadres, issued by the Saudi Commission for Health Specialties.
- The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within seven working days.

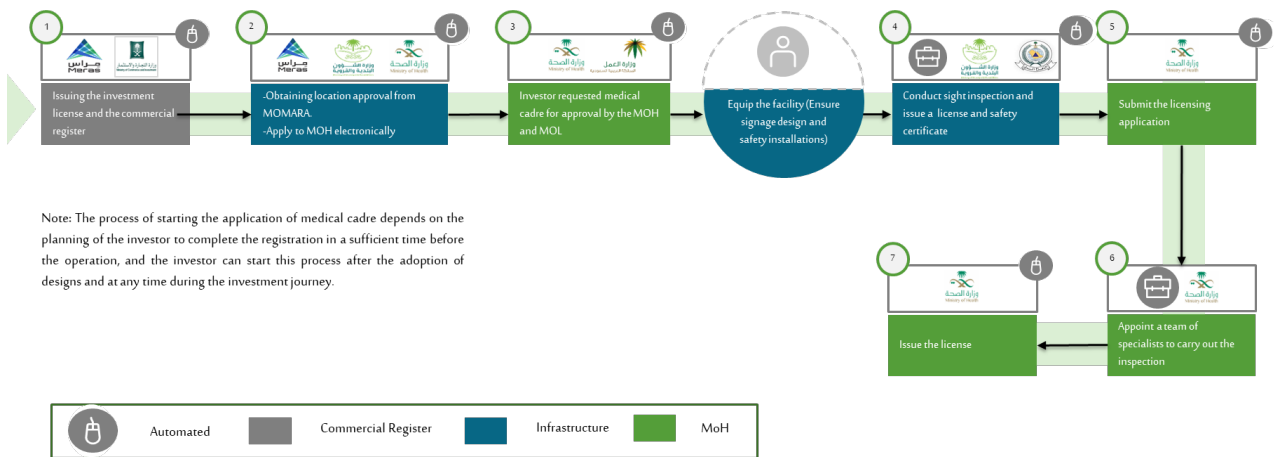

Laboratory Establishment Licensing

Laboratory:

A dedicated space where laboratory and medical examinations and tests are carried out.

Laboratory License Issuance Requirements



First Step: Prerequisites for Applying for a General / Specialized Laboratory License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

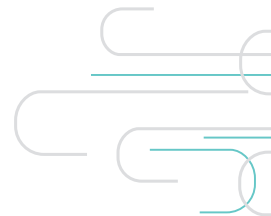
Second Step: Requirements for Initial General/Specialized Laboratory Approval Issuance

The general/specialized laboratory establishment application shall be submitted through SEHA platform, indicating the facility type, and to which the following documents shall be attached:

- A copy of the investor's ID in the event of an individual ownership ,(or a copy of the company's Article of Association, along with the partners' IDs (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.



Fourth Step: General / Specialized Laboratory License Issuance Requirements

Upon the completion of all medical and administrative requirements of the general/specialized laboratory, the investor shall apply for the license ,while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
 - Copies of the classification of medical cadres, issued by the Saudi Commission for Health Specialties.
- The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within seven working days.

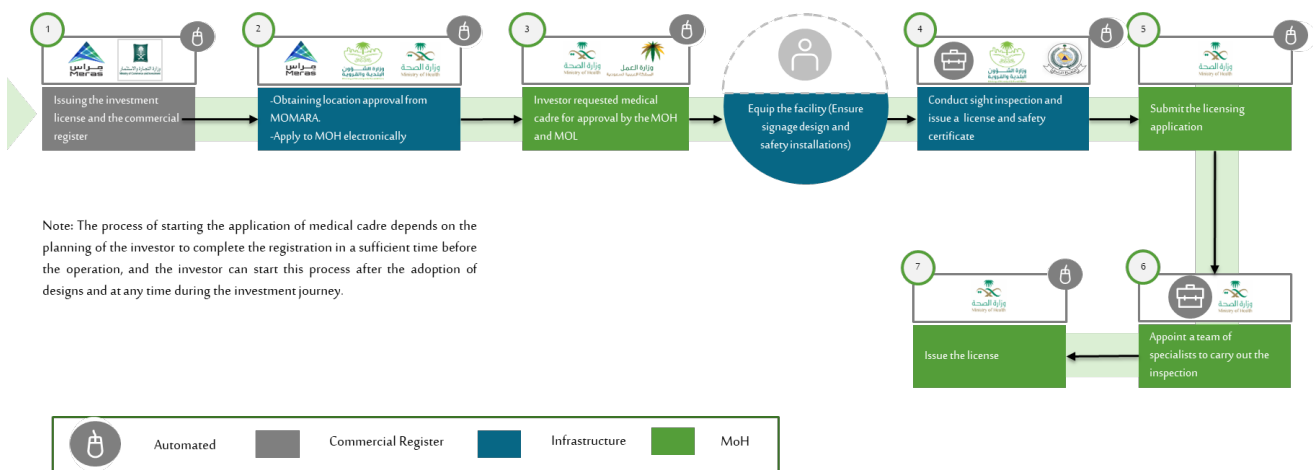

One-day Surgery Center Licensing

One-day surgery center:

In an outpatient surgery center, surgical procedures are performed, and anesthesia and immediate post-surgery recovery services are provided to outpatients. In this respect, the outpatient surgery center can contain one or more operating rooms.

Requirements for One-day Surgery Center License Issuance



First Step: Prerequisites for Applying for an One-day Surgery Center License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

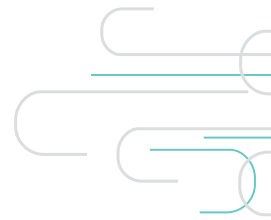
Second Step: Requirements for Initial One-day Surgery Center Approval Issuance

The One-day Surgery center establishment application shall be submitted through SEHA platform, indicating the facility type ,and to which the following documents shall be attached:

- A copy of the investor's ID (in the event of an individual ownership), or a copy of the company's Article of Association, along with the partners' IDs (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.



Fourth Step: One-day Surgery Center License Issuance Requirements

Upon the completion of all medical and administrative requirements of the one-day surgery center, the investor shall apply for the license, while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification of medical cadres issued by the Saudi Commission for Health Specialties.
- A valid agreement with a private or governmental hospital to accept emergency cases.
- An acknowledgment not to allow patients to stay in the center overnight.
- An acknowledgment from the Physician to be licensed to assume full responsibility for any negligence occurring to patients.
- A list of operations the Physician will perform.

The license shall be issued once:

- The facility site is inspected and all requirements and medical cadres required are provided.
- The approval of the Assistant Undersecretary of Health Investment Development on the consultant Physician's one-day surgery performance is obtained within 14 working days.

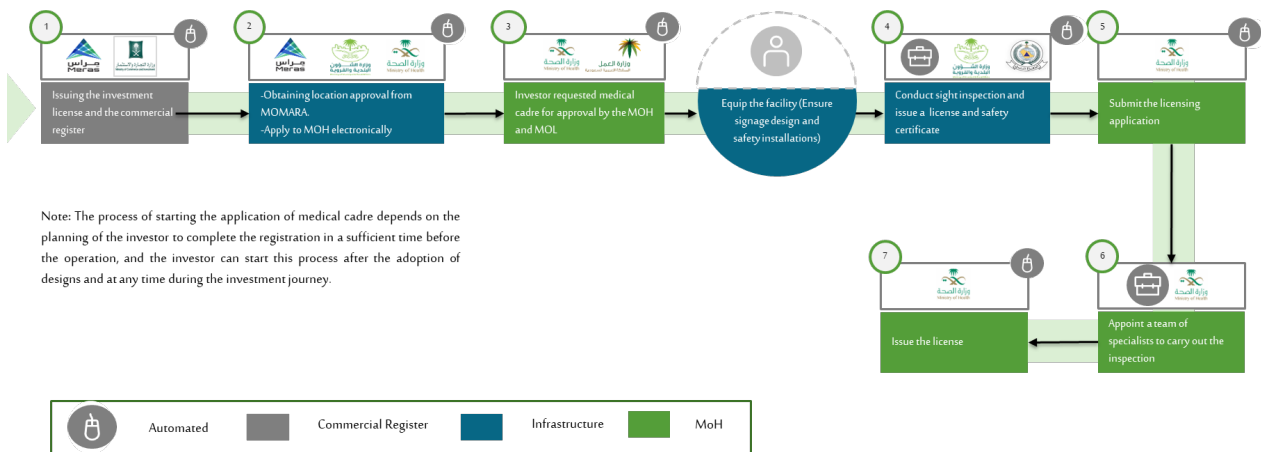

Medical Clinic Licensing:

Medical clinic:

A private health facility, designed to receive and undergo patients to necessary medical examinations, tests and treatments, and owned and supervised by a specialized Physician with a valid professional practicing license. In this respect, the medical clinic shall be completely equipped.

First Step: Prerequisites for Applying for a Medical Clinic License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

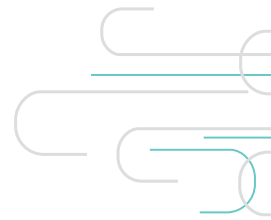
Second Step: Requirements for Initial Medical Clinic Approval Issuance

The medical clinic establishment application shall be submitted through SEHA platform, indicating the facility type, and to which the following documents shall be attached:

- A copy of the investor (Physician) ID.
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.



Fourth Step: Medical Clinic License Issuance Requirements

Upon the completion of all medical and administrative requirements of the medical clinic, the Physician shall apply for the license, while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification of medical cadres, issued by the Saudi Commission for Health Specialties.

The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within five working days.

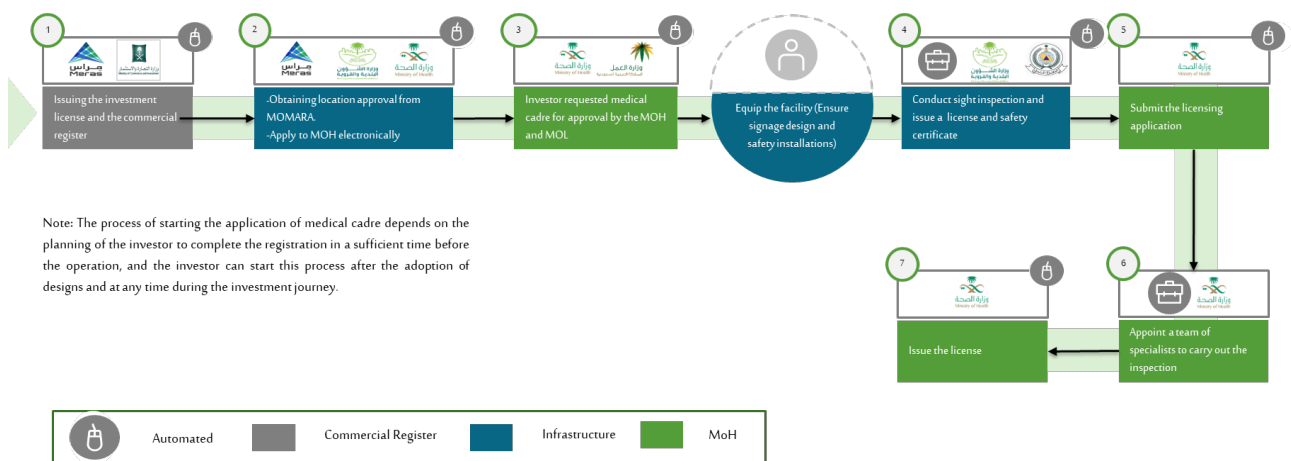

Ambulance transport services center Licensing

Ambulance transport services center:

A center conforming to the approved regulatory specifications of the Saudi Red Crescent, in charge of providing on-site emergency services prior to transferring the cases to respective health facilities.

First Step: Prerequisites for Applying for an Ambulance transport services center License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

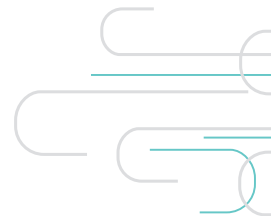
Second Step: Requirements for Initial Ambulance transport services center Approval Issuance

The Ambulance transport services center establishment application shall be submitted through SEHA platform, indicating the facility type, and to which the following documents shall be attached:

- A copy of the investor's ID (in the event of an individual ownership), or a copy of the company's Article of Association, along with the partners' IDs (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs 'medical cadres to the Ministry of



Labor and Social Development electronically.

- Obtain the permit of the Ministry of Municipal and Rural Affairs.

Fourth Step: Emergency Transport Center License Issuance Requirements

Upon the completion of all medical and administrative requirements of the facility ,the investor shall apply for the license ,while ensuring the attachment of the following documents:

- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification of medical cadres, issued by the Saudi Commission for Health Specialties.

The license shall be issued once the facility site is inspected and all requirements, equipment and medical cadres required to operate the facility are provided, within seven working days.

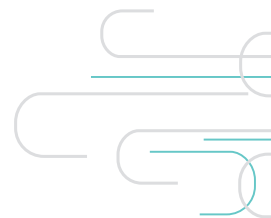

<p>Physiotherapy centers:</p>	<p>A private, complementary health facility, designed to treat mobile problems and disorders and pathological conditions using different therapeutic and physical exercises.</p>		
<p>Occupational therapy:</p>	<p>A private, complementary health facility, based on the assessment and treatment of the daily life skills of people with physical, neurological or cognitive problems, by developing, restoring or maintaining their abilities from regression.</p>		
<p>Prostheses and orthodontic devices centers:</p>	<p>A private health facility, designed to ensure the manufacturing and fitting of prostheses to serve patients suffering from a partial or total amputation of a limb, as well as to offer orthopedic equipment to people with special needs, in addition to other post-orthopedic rehabilitation services as well.</p>		
<p>Speech and swallowing treatment centers:</p>	<p>A private health facility, designed to assess and diagnoses speech and swallowing disorders, as well as to identify each patient's capabilities and provide necessary treatment to restore and improve language, sound, speech fluency and swallowing problems, through the use of specialized Physicians and specialists.</p>		

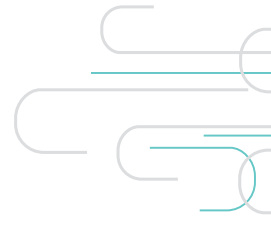




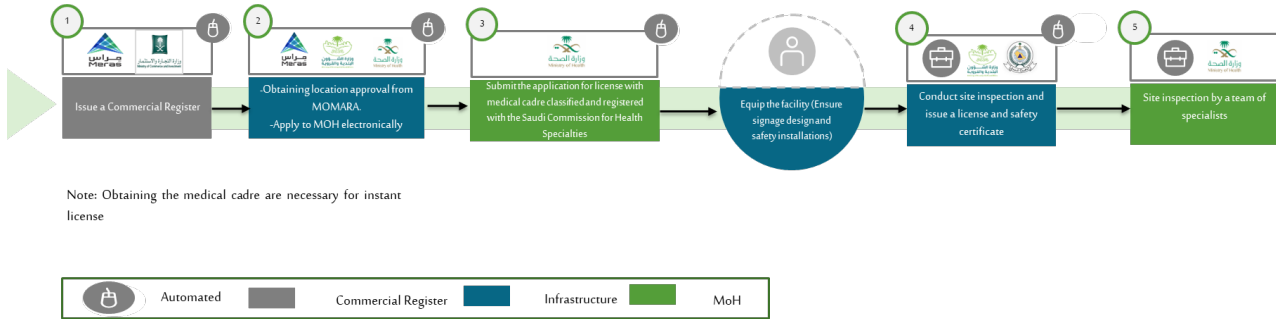
Activity	Definition
Hearing Therapy Center:	A private health facility, designed to diagnose, assess and rehabilitate patients with hearing disorders, as well as to prescribe hearing aids for hearing impairment and ear tinnitus cases, and to conduct balance rehabilitation sessions for patients in need.
Optical Retail:	A private health facility, designed to ensure eyesight and vision examination, as well as to provide medical and sun glasses by dedicated Physicians, specialists and technicians who refrain from diagnosing diseases, prescribing medications or treating eye diseases. In this respect, optical shops are classified into three categories, namely A, B and C.
Dental labs and industrial installations:	A private health facility, designed to manufacture removable and non-removable dental prostheses and ceramics, among others, in accordance with relevant, applicable rules and regulations.
Foot and Ankle Care Center:	A private health facility, designed to detect, diagnose and treat ankle and foot problems, especially with patients suffering from flatness and diabetes.
Nutrition center:	A dedicated space, designed to receive visitors, as well as to provide food consultations and nutrition education counseling, while offering meal preparation solutions in line with their health requirements.
Urgent Care Centers:	A private health facility, designed to provide medical care services to treat minor illnesses and injuries in an independent medical facility. In this respect, medical service providers - working within the urgent medical care center - aim at fulfilling the patients' needs through effective means, while seeking to minimize waiting time. Furthermore, urgent medical caregivers do not aim at providing emergency intervention solutions to treat critical, serious, life-threatening cases potentially-disabling situations.
Mobile clinic:	A private health facility, designed to deliver preventive or curative health services to some patients in remote areas, in which some services are not available.
Telemedicine and Telehealth Center:	A private health facility, designed to use a range of modern electronic technologies, such as multimedia, e-mail and smart applications, by health facilities or practitioners, so as to enable safe and direct communication between the patients and health practitioners to assess their medical conditions and provide necessary treatment thereto.

<p>Home Care Center:</p>	<p>A private health facility, designed to provide patients with health care services in the comfort of their homes, through a group of Physicians, nurses and specialists. Patients are, therefore, provided with necessary equipment, medicines and dressings under the supervision of a specialized Physician.</p>
<p>Pain Management Center:</p>	<p>A private health facility, designed to diagnose and treat chronic pain, while providing necessary psychological and behavioral support and managing complex pain disorders through the adoption of a specific, multidisciplinary approach.</p>
<p>Specialized Center for Addictions and Rehabilitation:</p>	<p>A private health facility, designed to provide addicted patients with medically-recognized rehabilitation and guidance services, in accordance with specific programs carried out upon detoxification and treatment, in line with applicable treatment and rehabilitation controls respected within private health institutions.</p>
<p>Psychotherapy and Rehabilitation Center:</p>	<p>Psychological rehabilitation and therapy centers are divided into the following two categories:</p> <p>Clinical psychotherapy centers:</p> <p>Centers in which clinical psychology specialists operate, to provide non-pharmacological assessment, diagnosis and treatment services, in accordance with internationally-recognized treatment methods adopted in the clinical psychology field.</p> <p>Psychological counseling centers:</p> <p>Centers in which counseling psychologists operate, to provide relevant services to deal with psychological problems resulting from disrupted social relationships and adaptation patterns (such as family, marital and personal relationships), psychological trauma (such as child abuse and domestic violence), and other psychological symptoms (such as anxiety, depression and eating disorders), in accordance with internationally-recognized methods.</p>
<p>Renal Dialysis Center:</p>	<p>A licensed, dialysis facility, designed to provide outpatients with medical, dialysis services on a short or long-term basis, while providing home dialysis training.</p>





Support Health Services Center License Issuance Requirements



First Step: Prerequisites for Applying for a Support Health Services Center License

- Obtain a Commercial Registration from the Ministry of Commerce and Investment.
- Obtain the approval of the Ministry of Municipal and Rural Affairs on the location's suitability.

Second Step: Requirements for Initial Support Health Services Center Approval Issuance

The support health services center establishment application shall be submitted through SEHA platform, indicating the facility type ,and to which the following documents shall be attached:

- A copy of the investor's ID) in the event of an individual ownership ,(or a copy of the company's Article of Association, along with the partners' IDs (in the event of collective ownership).
- A copy of the lease or title deed.

Third Step: Issuance of Relevant Licenses and Approvals

- Obtain and submit the approval of the Directorate of Health Affairs' medical cadres to the Ministry of Labor and Social Development electronically.
- Obtain the permit of the Ministry of Municipal and Rural Affairs.

Fourth Step: Support Health Services Center License Issuance Requirements

Upon the completion of all medical and administrative requirements of the support health services center, the investor shall apply for the license ,while ensuring the attachment of the following documents:

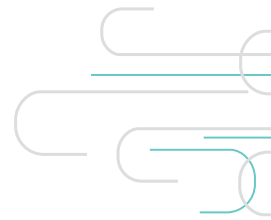
- A copy of the permit of the Ministry of Municipal and Rural Affairs.
- Copies of the classification of health medical cadres, issued by the Saudi Commission for Health Specialities.

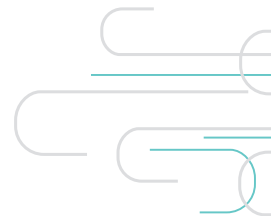
