Accreditation body	Authoritative body that performs accreditation [ISO/IEC 17000]
Actor	Information systems or components of information systems that produce, manage, or act on information associated with clinical and operational activities in the enterprise.
Amended Partial Report	Report which is released and then updated prior to all of the requested tests being completed. The report validation process has been performed prior to the partial report being released and again before the amended report is released.
Amended Report	Updated report which is released after all of the requested tests have been completed.
Anonymization	Process that removes the association between the identifying data set and the data subject. [ISO/TS 25237]
Antecedent Data	Data from an Antecedent event is an in-person proofing event that occurred previously and shall suffice as meeting the present in-person identity proofing requirements.
Anesthesia Consult	The mechanism by which a surgeon requests an anesthesiologist to review the patient case and make recommendations as to the anesthesia requirements for the patient operation.
Anesthesia Note	Document produced by an anesthesia who participated in a surgical intervention, and which contains a detailed account of the anesthesia and related activities. This record is currently stored locally.
Apgar	Numerical measure of the physical health of a newborn infant derived by evaluating heart rate, muscle tone, respiratory effort, response to stimulation, skin color, and other physiological indicators.
Assurance	In the context of NIST SP 800-63, assurance is defined as 1) the degree of confidence in the vetting process used to establish the identity of an individual to whom the credential was issued, and 2) the degree of confidence that the individual who uses the credential is the individual to whom the credential was issued. [NIST 800-63-1]
Attestation	Issue of a statement, based on a decision following review (5.1), that fulfillment of specified requirements (3.1) has been demonstrated [ISO/IEC 17000]
Audit	Systematic and independent examination of accesses, additions, or alterations to electronic health records to determine whether the activities were conducted, and the data were collected, used, retained or disclosed according to organizational standard operating procedures, policies, good clinical practice, and applicable regulatory requirement(s). [ISO 27789]
Audit Log	Chronological sequence of audit records, each of which contains data about a specific event. [ISO 27789]

Business Process Model	Analytical representation or illustration of an Use Case's business processes
Business Scenarios	Sequence of activities by one or more users (e.g. patients, clinicians, etc.) that describe a real-world story. A business scenario executes one or more business processes in a sequence of end-user interactions called a process flow. Business scenarios are the starting point of the analysis leading to the discovery of actors and services necessary to meet the requirements of the assigned use case.
Certificate of Conformity	Document certified by a competent authority that the supplied good or service meets the required specifications
Certification Authority (CA)	Authority trusted by one or more users to create and assign public-key certificates. [ISO-9594-8].
